Leaders in Workforce Development

In Spring 2009, the Guam Community College will begin its first ever "Connecting with the Community" Capital Campaign. With thousands of alumni and friends to help with their volunteer support and financial contributions we hope to see a successful completion of this campaign in one year.

The success of this Campaign cannot be measured in mere dollars because of the impact on the College has been far greater in recruiting and retaining the very best faculty and students for Guam Community College.

There are still many dreams that can only be successfully related through private funding.

- We continue to remain a fiscally responsible Government Agency, "making strides as a low-risk auditee".
- We must establish more scholarships to continue to attract students and encourage them to remain in Guam and use their talents for the betterment of our Island.
- We must expand our programs and create more faculty positions to meet our mandate as the State Agency for Vocational Education for secondary and post secondary students.
- We must build new facilities that will provide lecture halls and study areas for our growing student body, offices, and laboratories for our world-class faculty.

To meet these challenges, GCC's Capital Campaign Goal of \$4.3 million must be reached by the end of 2010. The College will continue to seek other sources of funding, matching money for private contributions, making this an excellent opportunity to double the impact of donor's personal gifts. INTRODUCTION

The Guam Community College campus has fifteen (15) permanent concrete buildings and temporary wooden buildings. Of the fifteen (15) permanent concrete buildings, three are new construction and the other twelve (12) buildings were constructed around the 1960s to 1980s. Although, only two temporary wooden buildings built in the 1960s remain, the oldest buildings on the campus are Buildings 100, 200, 300, 500, and 600. There exists a disconnection between existing buildings which is reinforced by the vehicular access roads that run through the campus. With no current Student Services Center it is difficult and dangerous (because of roads within campus), for students to complete their admissions and registration process. Instead the college locates the various student services in various locations around the campus. These services includes: 1) Student Support Services: located in 'B' building, 2) Library: located in Foundation building, 3) Bookstore: located in building 200, and 4) Health Services: located in a temporary building structure. Several of these services should be centralized in order to provide GCC students with a seamless admissions and registration process and student services activities.

In March of 2005, Taniguchi Ruth Makio Architects (TRMA) were contracted to develop a Guam Community College 2005 Physical Master Plan Report forecasting the growth of the campus facilities necessary to accommodate the college's anticipated needs with a 15% anticipation population growth over the next 15 years. The Report's recommendation to build on the existing campus, within Phases, with the "ideal" scenario, included the Student Center as the first item on Phase 1B. It cited the need to include construct a 2-story - 11,000 square feet (s.f.) per floor, pre-cast concrete walls and metal roof. Below is the preliminary space identified by TRMA for the Student Center Building in the 2005 Physical Master Plan Report.

Plaza and Student Square: 36,000 s.f.

Lounge/Lobby: 3,400 s.f.

Bookstore: 1,000 s.f.

Rooms: 1,000 s.f./9 each

Storage: 800 s.f. Restrooms: 600 s.f.

BUILDING STRUCTURE NEEDS

The Student Center will provide GCC's students with the support services necessary to assist and ensure the successful accomplishment of each student's educational goals in their academic course or program. With the 15% student population projection from the TRMA Report, it is vital that GCC identify funding sources to pursue the construction of a Student Center. The significant problems below have been identified by GCC students, faculty, staff and administrators to justify the need for a Student Center.


Scattered Services: Currently, GCC conducts admissions and registration process in various locations in order for a student to complete enrollment. The various student services are located around the campus. These services includes: 1) Student Support Services: located in 'B' building (for student ID, etc.), 2) Library: located in Foundation building, 3) Bookstore: located in building 200, and 4) Health Services: located in a temporary building structure. Several of these services such as admissions and registration, student ID, bookstore, security and others provided by the college, should be centralized in order to provide GCC students with a seamless enrollment process and accessible to student services activities information.


PROJECTED BUILDING COST


The projected construction cost for a Student Center Building was submitted by Taniguchi Ruth Makio Architects in October 2008 in anticipation to identify funding sources.



Matching gifts and pledges apply toward gift recognition.

As the Builder of Education, you take pride in providing the foundation to instill skills that will empower students and prepare them for the workforce through your contributions in the amount of \$1,000 to \$9,999.

Circle of Students/Alumni

As members of the Student/Alumni Circle, you will be setting the pathway for all our future students to succeed through your contributions in the amount of \$100 to \$999.

Selecting the best gift plan depends on your personal financial situation and goals. As tax laws are always changing and each individual's situation is unique, you are encouraged to consult with financial advisors to determine which method of contributing is most beneficial to you.

There are many ways of giving so that you are able to meet your needs, those of your family and have the opportunity to give to the Guam Community College Foundation. Pledges are commitments made in good faith, but are not legally binding. You may want to consider stretching your pledge over a five-year pledge period to maximize the total amount of your support. We encourage all donors to consider 10-20 percent initial payment to begin your commitment.

Gifts made by cash or check are the most common and will allow the Guam Community College Foundation to address its immediate needs. However, while the needs of the "Connecting with the Community" Capital Campaign are urgent, we will gratefully accept gifts in various forms, including those described below:

Bequests – Bequests may be made through your will and may include a specific dollar amount or a percentage of your estate.

Life Insurance – You may donate to the campaign by making the Guam Community College Foundation the owner and beneficiary of your insurance policy.

Securities – A gift of appreciated stock is most advantageous form of giving. For example, if yo donate stock purchased for \$2,000 that you have owned 12 months or more, and the stock is now worth \$10,000, your tax deduction will be for the full \$10,000 and a tax savings of \$3,100 (31% marginal bracket). In addition, you have avoided the capital gains tax (combined 20% rate - \$1,600) on the appreciation of the stock. Your total savings in this example is \$4,700.


Real Estate – Gifts of appreciated real estate are similar to gifts of stock. If you have owned the property for 12 months or more, you avoid capital gains taxes and may deduct the fair market value of the property.

Charitable Lead Trusts – Charitable Lead Trusts are funded with an asset, such as appreciated property or securities, and the earnings are contributed to the Guam Community College Foundation for the life of the trust. When the trust reaches its termination date, the principal goes to your beneficiaries.

Charitable Remainder Trusts – Similar to Charitable Lead Trusts, Charitable Remainder Trusts are funded with an asset and the earnings are paid as income to you and your beneficiaries. Upon the death of the last beneficiary, the principal goes to the Guam Community College Foundation.

Please remember that payments on pledges are deductible for income tax purposes as provided by law. Can I choose how my gift is used?

How can I participate? Can I pledge over time?



Our campaign offers a wide range of gift opportunities to participate at all levels. You may choose a plan that provides you with both flexibility and time to complete the payment of your pledge. Because our needs are

urgent, we encourage you to complete your pledge within five years.



Is my pledge legally binding? Will it be confidential?

No, a pledge is a gift, one you consider to be meaningful to you. All we ask is that you do your best and advise us of any financial changes that will impact your pledge. All pledges will be kept confidential as possible. Only the people responsible for maintaining the records will have access to your pledge.

To what extent are campaign commitments tax deductible?

Gifts to the campaign are tax deductible to the fullest extent of the law. The application of such laws varies with individual

circumstances. Donors with specific questions regarding tax deductibility should contact their attorneys.

Who will be asked to support the "Connecting with the Community" Capital Campaign?

All alumni, parents, friends, corporations, foundations, and many others will be asked for consideration of a gift to the campaign.

How will the campaign effect my annual giving?

Annual giving will continue to provide support for ongoing academic programs. During the campaign, volunteers will ask everyone to make pledges. In the long term, similar campaigns will continue causing an increase in annual giving pledges to raise the sights of donors.

Are pledges the only kind of gifts?

While such gifts will be the type most often made to the campaign, other types such as gifts of stock or deferred gifts are also options.

Can trust and estate gifts be made to the "Connecting with the Community" Capital Campaign?

Because the needs of the campaign require immediate funding, gifts of cash and securities are generally sought. If you would like to support the campaign by offering a planned gift, please contact the Development & Alumni Relations Office to discuss the options available in making such a gift.

Did you know...


