## GUAM COMMUNITY COLLEGE Board of Trustees Monthly Meeting of January 8, 2009

#### Minutes

The monthly meeting of January 8, 2009 was called to order at 6:15 p.m., by Acting Chairperson Maria Dilanco Garcia. The meeting was held in the President's Conference Room located at the Student Services & Administration Building.

#### II. APPROVAL OF MINUTES

I. December 4, 2008 Meeting

#### **MOTION**

- V. REPORTS
  - 1. President's Report:

#### Financial Status of the College:

• <u>FY2009 Appropriations</u>: President Okada reported the unfortunate news regarding GCC's budget request and release of appropriations. For the first three months of FY2009 (Oct-Dec 2008), GCC only received \$1.3 million out of the \$4.8 million it requested for FY2009. She emphasized that due to GCC being able to secure some federal draw downs as well as liquidate some of its Time Certificates of Deposits (TCD), GCC was able to meet its December payroll.

Further, President Okada reported that due to the College's current financial status, management was required to do the following:

- No hiring of vacated positions since October 1, 2008.
- Re-alignment of vacant positions under federal programs, i.e., moving a college employee previously funded by local funds to carry out the activities of various federal grants to prevent losing the grant(s). She emphasized that the re-alignment of employees has caused some strain on the other locally funded employees of the college because they now have to pick up the load of the transferred employee.

President Okada assured the Board that the college continues to work and follow up with the Department of Administration and the Bureau of Budget Management Research on GCC's releases. She requested the Board's help and support to work with the Governor's administration in the release of GCC's money.

<u>FY2008 status:</u> President Okada reiterated that GCC was able to reconcile its books with the
Department of Administration resulting in the amount of \$331,000 due to GCC. This amount is
expected to be released to GCC.

## Capital Improvement Projects on Campus, FY2009:

• At the request of GCC, the Guam Fire Department (GFD) conducted an inspection of the campus early this month. In the report from GFD, President Okada noted that the one concern cited by GFD was that GCC is operating without a Fire Alarm System. She assured the Board that the college is working on addressing the issue and a re-inspection by GFD will be conducted. Additionally, a request was also made to Public Health to conduct an inspection. The date is yet to be scheduled.

National Council of State Directors of Adult Education (NCSDAE): President Okada happily shared that information from NCSDAE is that Guam & GCC were highlighted in the Transition Team's report regarding the economic recovery packages relating to health, education, training and employment. In the report it cited that GCC be looked at based on how the institution and its adult education programs tie into postsecondary & career technical education.

Additionally, she shared that GCC's Continuing Education office continues to work with Anderson Air Force Base relative to military staff employee training to be held sometime in February or March of this year.

<u>Bill 390</u> relative to the establishment of the Postsecondary Council has been passed by the Guam Legislature and is now with the Governor for approval.

## 2. Monthly Activities Report

Student Trustee: Ms. Charlene Flores reported on the following:

- Over the Winter break, aluminum cans and plastic recycling bins were placed around campus by GCC's various student organizations.
- January 6-9, 2009: GCC's Express Registration held from 8:00 a.m. 5:00 p.m., in the GCC Multipurpose Auditorium.
- January 7, 2009 a new Student Orientation was held with over 100 students in attendance.

## Faculty Advisory Member: Mr. Barry Mead reported on the following.

 In referring to President Okada's financial status report on the college, Mr. Mead reiterated the severity of the financial issue. He emphasized that along with the report of payroll potentially not being met it also prevents us from paying our vendors which in elfect hampers our programs i.e., not able to purchase supplies needed in the classrooms, potential internet disconnection, etc.

At this time, President Okada briefly noted that a strategic planning session was held with the Faculty Senate on December 5. Based on the financial situation the college is currently faced with, some of the options discussed and identified include not to offer Summer session this year, to hold back on the increase of tuition, and to develop a GCC Land Use Plan (314 acres).

With regard to the development of a GCC Land Use Plan, she emphasized that the Obama Presidential Transition Team has identified that economic stimulus is best suited when partnered or positioned through higher education. Therefore, colleges & universities across the United States will be used as a vehicle to stimulate the economy. It is expected that the amount of money that will be made available to community colleges will significantly be increased.

Support Staff Advisory Member: Ken Bautista reported on the following:

Registration for Spring 2009 currently ongoing.

## VI. UNFINISHED BUSINESS

1. New Allied Health Bullding (Update)

President Okada reiterated that several months ago, GCC had asked the Governor to request from the Department of Interior to consider re-programming funds to the Allied Health Center. Therefore, GCC received official notification that the amount of \$943,000 has been authorized and will be re-directed to fund GCC's Allied Health Center. Board members are welcomed to view photos of the construction of the Allied Health Center on GCC's website @ www.guamcc.cdu.

## 2. New Student Center (Update)

President Okada reported that she had a meeting with Mr. Joe Diego from the U.S. Department of Agriculture regarding potential funding opportunities for the Student Center. Discussions centered on three options: 1) Potential financing of just the Student Center, 2) Financing of the additional money needed for the extension of GCC's Learning Resource Center (LRC), and 3) Potential financing for both the Student Center and the Learning Resource Center extension project. Upon receipt of the matrix from Mr. Diego, President Okada will make a presentation to the Foundation Board of Governors at their next meeting for consideration.

For the record, referring to Board Policy 465 "Emeriti at Guam Community College," Mr. Mead reiterated that as discussed at the Board's last work session on the review of policies, he is to present the policy to faculty for feedback, and upon presentation of faculty feedback to the Board, the Board will be asked to consider amending Policy 465.

Additionally, Attorney Hopkins again recommended that all board policies referencing Public 14-77 and other public laws be replaced with the appropriate language, i.e., codification of laws (Guam Code Annotated). Members concurred.

At this time, President Okada noted that there is a possibility that the travel cost for Board members who are scheduled to attend the ACCT Summit may potentially be federally funded by the Pacific Postsecondary Education Council (PPEC). She said because several other colleges requested for their board's to attend

the ACCT Summit, she also included GCC's Board. President Okada's travel to the Summit is covered by PPEC.
