

Board of Trustees Quarterly Report for April – June 2010

1. **Accommodative Services** – The vacancy for the Program Specialist still remains but the position has been announced and the applications are being evaluated. It is hoped interviews will occur before the end of June. In the meantime, the Dean is reviewing all requests for accommodations and streamlining functions to serve students.
2. **Assessment and Counseling** – The department has requested and provided sufficient evidence to fill the vacancy at Simon Sanchez High School and has demonstrated a need for a CTE counselor at Okkodo. In addition to the regular duties on campus, several counselors participated in training our students at multiple events.
3. **Business Department** – The Department has been divided beginning Fall 2010. Office Technology will join the Technology Department and Accounting and Supervision and Management will join Marketing and Visual Communications. The vacancy left by Julie Cruz-Jones will be filled in June to begin Fall '10. Our student accounting intern at Shell was awarded at \$500 stipend for their work.
4. **Center for Student Involvement** – The spring fling was held in April and there was a great turnout for voting. The student trustee is Paling and there is a complete group for student officers of COPSA. Induction and leadership training for the officers was held in May and June. The Program Specialist will be leaving on June 20 for Skills USA.
5. **Civic Engagement** – The Center for Civic Engagement and student success have been working to keep our Americorps volunteer tutors busy meeting the needs of students seeking assistance. In addition they continue to do presentations of service learning and assist faculty with culminating activities that allow students to share their reflections. The Vista Student Volunteer attended training in Hawaii with the Hawaii Islands Pacific Islands Campus Compact (HIPICC).
6. **College Access Challenge Grant** – The CACGP currently has a waiting list for students in the summer bridge – they have 33 middle school students and 27 high school. The energy of this department is contagious and they have successfully recruited over 700 participants. There is great communication with the schools and great tutor participation.
7. **English** – The name of the Department is officially changed from ELI to English. Judy Salas will be retiring and completed her last semester this Spring. Lisa Baza-Cruz will be the incoming Department Chairperson. The department is focusing on moving out of classrooms they currently occupy in the F Bldg in order to prepare for Fall semester.
8. **Enrollment Services** – This office chaired the College Fair held on April 2nd where over 100 high school seniors were introduced to GCC and were able to talk about college with faculty, financial aid, counselors and the admissions and registration personnel.
9. **Health Services** – Clinic Visits based on the center's sign-in sheets: 1,756 students, 228 employees and 1 visitor for a Total: 1,985. Health Clearances --Tuberculosis(TB) Clearance and Immunizations: Majority of the visits were for clearances. Immunization audit and counseling were conducted in conjunction with TB clearance (MMR vaccines were also provided). Nurse

Cecilia also provided an article for Chachalani on Mumps and both nurses presented for new employee orientation.

10. **Library** – The furniture requirements have been submitted to Procurement for bid preparation so the furniture can be here in time for the opening of the new LRC. The committee meets weekly to review the progress on construction. The library has some concerns about their collection and is trying to find new ways to increase it.
11. **Math, Science, Cosmetology**- Cosmetology will be moving to the Education Department to align with the Career Cluster on Human Services (Early Childhood Education is considered a human services). The Department has written a chemistry course guide and a microbiology course guide. Interviews will be held for both math and science.
12. **Student Support Services** – William Melendez Jr. passed away at the end of May. He really was the anchor for that office and the staff have been taking the loss hard. Mr. John Payne has really been stepping up and managing all of the services and is really supported by his staff. There have been a few recent incidences of theft or vandalism and the office is reevaluating the security guard needs.
13. **Technology** – Multiple course guides were submitted to revamp the computer science course offerings. In addition, all course guides for the Microsoft IT program were completed and approved through the curriculum committee. Course offerings were to begin this summer but will start in Fall.
14. **Trio Programs**- Year-end activities were held at the Hilton and the event was quite successful with about 10 graduates. Upon completion of that event, focus switched to recruiting for a summer bridge program that introduces high school graduates to college life. The office has been working hard to fill the available slots.

Adult Education – A total of 25 students passed the GED during April and May. A total of 182 students took post tests in ABE classes.

Allied Health – Practical Nursing Program Director Louise Foster was chosen by the NCLEX committee to attend meetings in Chicago to help write questions for upcoming NCLEX examinations. Instructor Dee Manglona attended a nursing conference in Palau. A medical assisting student, Ken Banico, is attending the SkillsUSA competition in Kansas City.

Apprenticeship – There are currently 348 apprentices working for 54 different employers. Standards for three more employers are in the works.

Automotive – The computer-trainer lab has been reconfigured so that it can also serve as a classroom to accommodate the diesel program. Diesel equipment has been ordered and is on the way. A post secondary student, Ray dela Peret, is attending the SkillsUSA competition in Kansas City.

Construction Trades – More Earmark boot camps were held successfully with a graduation held in early June.


Criminal Justice and Social Science – A summer supplemental police cycle is underway with 31 students enrolled. Public Health ARRA funding is going to pay for most of them.

Education – The new secondary early childhood program for GW had a successful first semester. Educational methods classes were run this summer for incoming GCC faculty.

Marketing/VisCom – Department realignments have added supervision and management as well as accounting to the Marketing and Visual Communications department. Long time GCC Marketing faculty member Rick Skipper has retired.

Tourism & Hospitality – Six students, both secondary and post secondary, are attending the Skills USA competition in Kansas City in the areas of culinary, commercial baking, and food and beverage service. They are Ruel Abastas, Kanani Abe, Catina Hansen, Reymart Manaois, Bertina Mendiola, and Kennylyn Miranda.

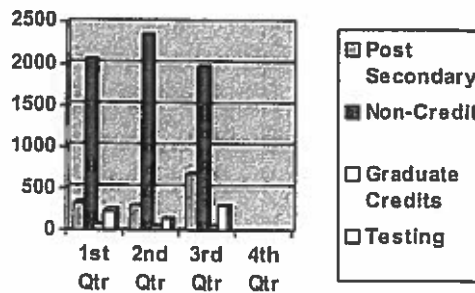
