The CCR seeks to provide government financial information to its citizens in forms that are clear and understandable, updated regularly and often, delivered to all, easy to locate, honest in breadth and technically accurate in detail.

Clery Act Reports

The Jeanne Clery Disclosure of Campus Crime Statistics Act (Clery Act), signed in 1990, is a federal statute codified at 20 U.S.C. § 1992(f) with implementing regulations in the U.S.Code of Federal Regulations at 34 C.F.R. 668.46.

The Clery Act requires all colleges and universities that participate in federal financial aid programs to keep and disclose information about crime on and near their respective campuses.

The law is named after Jeanne Clery, a 19-year-old Lehigh University student whom was raped and murdered in her campus hall of residence in 1986.
