- 1. Conversation related to Faculty Senate:
 - We were informed today via AVP Dr. Gina that no new official members can be added to Faculty Senate until F22: "Because the commitment to serve on a committee is for an academic year, to ensure the seamless work of each committee and because of workload implications, I suggest that potential members complete the interest forms for the next academic year. Workloads for spring 2022 have already been approved by the Deans. As for DC participation in FS, that can be done regardless of membership."
 - Carl mentioned that there should be a way to cut through this, since there are only two 'official' members of FS (Kathy C. and myself).
 - We need to revise the bylaws to align with the contract, and we need to push for taking greater control over the 'vetting' of officers and elections.
 - Department Chairs are encouraged to participate in Faculty Senate conversations and meetings. Their input and ideas are important to helping Faculty Senate through this year of minimal membership (please, please, please!)
 - Department Chairs present indicated their interest in supporting Faculty Senate through attendance at meetings or other communication.
- 2. Concern regarding students (absences, dropping off the radar, not submitting work) which ultimately affects faculty who are being asked to accommodate students' needs due to Covid or other health (physical and mental) issues and deaths in family (Covid-related or other).
 - Carl noted that students in developmental level courses attend but don't complete work, in order to maintain financial aid payments.
 - Simone and Kennilynn noted that faculty in their departments have a "3-day absence" policy, wherein students are not penalized for the first 3 absences, but can lose -10% of their grades for each subsequent absence. Attendance affects participation within or during class time, which cannot be 'made up' outside of the class time. While attendance itself cannot be 'graded', their attendance is directly linked to participation. Note: This is not always the case, such as students may attend every class session but never or rarely actually contribute to discussions or activities. Nevertheless, at this point in time, attendance is the main objective measure of participation.

- For the ED department, most faculty (ED and ECE) set a limit of 5-7 absences for receiving credit for the course. It's a bit different for ASL and Cosmetology students/courses due to the nature of their class sessions and other requirements.
- It might be good if there was a bit more consistency across the programs/departments, although we recognize that each program will have specific hours linked to completion of their specific program.
- Absences alone are not the issue, since some students are attending but just not submitting assignments (or not enough to pass the course).
- We understand that folks are worn thin by this extended time of the pandemic and that we all need to be a bit flexible with our students. Nonetheless, it would be good if we could have more conversations on this topic in order to address increasing rates of students failing or dropping out to bring this forward to the administrative team rather than admin-driven mandates such as the one in \$2020 of providing Incomplete grades to many of the students.
- I am mentioning the possibility of incomplete grades to some students (whom I know were ill with Covid over several weeks or other extenuating circumstances), but students must initiate the process and provide documentation such as positive Covid tests. Considering incomplete grades affects faculty members as well, since we will need to help students in the subsequent semesters. This was a problem (especially last year) when we were being told to help monitor students completing coursework for courses they had been taking with adjunct faculty who were not working at GCC anymore.

3. College Assembly

- Carl brought this topic up to which others agreed with that perhaps College Assembly time could be either altered or dropped. For example, much of what is being presented could simply be sent in notices or shared as documents with faculty rather than using class days.
- At the very least, if we are required to meet on those days, the sessions should be more worthy of our time and taking from class/instructional time.
- If College Assembly is run during the day, there is a risk that Secondary faculty will not be included due to changes in GDOE schedules. This was the case this semester.
- There is a question as to the need for College Assembly days. There may be times/semesters when such times could be useful and helpful, such as times for folks to get together, or to share concerns/ideas; however, the day is usually taken up with reports (not relevant to all faculty) or sessions which faculty could look into on their own time. It is hoped that more time would be provided to have conversations that are relevant, meaningful, or supportive in nature for faculty/staff members.
- We would like other's input on this topic, so that we can make suggestions for S2022 before they plan another College Assembly day.

I think this was the gist of what was covered.
