

Program Assessment Report AY 19-20
Industry Certificate in Cosmetology



According to the memo by CCA released in Spring 2019, the Industry Certificate in Cosmetology was scheduled for program assessment in AY 2019-2020. This report (and that data) is to be uploaded to GCC's assessment software "Improve" in collaboration with the department chair.

In Spring 2019, there were 20 students enrolled in CM104A. During that semester, three students withdraw from either the course or the program. There were two students added to the program cohort to fill the seats of the students who withdrew from the program.

A total of 19 students completed the program. Five (5) finished the program early during the optional summer CEWD course (C_CM192). The other 14 students completed the program at the end of Fall 2019.

Out of the 19 students total, four (4) successfully passed the Guam Board of Barbering and Cosmetology's (GBBC's) state cosmetology licensing exam. Eight (8) students are awaiting results as they are sent off-island and there is a delay due to the Covid-19 health emergency. There were four (4) students who have not taken the exam. One (1) student did not successfully complete the program because the students did not complete all required hours for certifications.
