- C. National Average Credit Requirements for Programs as per C. Torres II email, he spoke with T. Dela Cruz and C. Dennis and they were supposed to contact P. Terlaje. However, no one has contacted P. Terlaje. P. Terlaje will prepare a timeline and attach to Faculty Senate End of Year Report.
- D. Elections for AY17-18 committees Friday, April 21, 2017 from 8:00am-3:30pm in Faculty Senate office, C2 election for PDRC and Advancement in Rank was conducted. Election results are as follows:

- A. AIER Institutional Set Standards (See Attachments)
  - 1. M. Montague provided research regarding Institutional Set Standards of certain benchmarks based on the Accreditors requirements. M. Montague requested for Faculty Senates feedback on

developing a score card for Guam Community College. AIER gathered 5 years of data and averaged it. Every year afterwards, 1% was added. Guam Community College is averaging at almost 70%. However, according to the US Education website, Guam Community College is marked at 7%, the second lowest in the nation.

- 2. Based on historical data Guam Community College has established a baseline. Requirement of ACCJC, is for Guam Community College to have a discussion on aspirational goals of the college. All discussion are to be recorded and inputted into minutes as evidence.
- 3. ACCJC also requires Guam Community College to track detailed information on SLO's for assessment purposes.
