I. Call to Order at 10:05 am by Dr. Mary Okada

II. Reports:

a. FY 2012 Appropriation Status – Dr. M. Okada

As of this date, the college, for fiscal year 2012, received:

\$10.6M of allotment from general fund

\$655K of allotment from general fund for the LPN program

\$600K zapped from manpower development fund (revenue did not come in, only 1,000 H2 workers on Guam)

\$21K for TAF

\$800K total allotment was received (\$20M was requested)

- **b.** FY 2013 Budget Dr. M. Okada
 - FY13 based on \$0.00 FY12 fund balances to Roll Over (except Incentive Funds)
 - \$20M requested from the Guam Legislature. \$15M was appropriated (\$2.4M set aside for reserve)
 - \$1.2M short for Salaries; \$3M short for Operations, Utilities, Contractual
 - Begin discussions on a contingency for FY14 Budget identify a strategy on what can the college do without or absorb some other way to get funding from the Legislature to operate the college
 - Invite students for a mass showing at Legislature for support of GCC's Budget
- **c.** Rising costs of Benefits/Utilities Dr. M. Okada
- **d.** ISMP Next Steps Dr. M. Okada
 - Throughout September October, mini-conversations took place with various stakeholders on updates to the ISMP Goals 1, 3, and 4. Updates will be presented on November 16 to the campus community.
- e. AIPs: #21 and #22 in ISER (Standard 4) Dr. R. Somera/J.Muna
 Based on AIP #21 and #22, the Management Team and the Job Specs/Faculty
 Evaluation Committee have been working together to factor in some recommendations
 for the Senate's review that would tie the AIPs into all Faculty evaluations particularly
 in the area of accountability of committees and of the Senate.
- **f.** Moving of CE for credit courses to regular term Dr. M. Okada/Dr. R. Somera JM provided comments, adding the question did it go through the Governance process? The roles of Faculty Senate, College Governing Council, Management were briefly

discussed. All were in agreement that certain Budgetary and Policy items are under Management's purview; while certain Academic items are under Faculty's purview.

g. Results of FA12 implementation of mass drop for student non-payments – Dr. M. Okada

10 students (63 dropped)
