Topics Discussed:

- **ACCJC's Proposed Accreditation Standards Revision:** Dr. Somera again encouraged feedback and comments on the proposed standards revisions from the standards committee members before its final adoption on the Commission's June 2014 meeting. The final adoption on the proposed revision will take effect on GCC's 2018 self evaluation report.
- **Spring 2014 Standards Committee Meeting Schedule:** The spring 2014 meeting schedule was discussed with the committee members. The spring schedule reflected make up meetings for January 2014 plus special meetings for those members who are unable to attend the regular scheduled monthly meetings. In discussing the spring meeting schedule, the standard 2 chair made a request on behalf of its members that if the chair of the standard and other members attended the regular scheduled meeting, the information disseminated and discussed at the regular meeting be passed on to the members who were unable to attend the regular meeting. Therefore, the members that did not attend the regular meeting wouldn't have to attend the special meeting. The self-study coordinator advised that the issue would be brought up to the ALO for his decision on the subject matter.
- **Mid-term Report Strategic Master Plan:** Self-Study coordinator again went over the mid-term report strategic plan to keep the members in the loop of the action steps needed for the completion of the 2015 mid-term report.

The form must be completed at the end of each semester and turned in to the AIER office.
