Topics Discussed:

- **ACCJC's Proposed Accreditation Standards Revision:** Committee members were advised that the deadline to submit comments on the revised standards is March 4, 2014. Members asked for clarification whether the new standards will be included on the 2015, mid-term report and were advised that the proposed standards if ratified will apply to the upcoming 2018 Self Evaluation Report.
- **Data Collection Mini Report:** Committee members were advised that the due date for the next data collection mini report will be on the last Friday of March (March 29) and the April mini report will also be due on the last Friday of the month (April 25). Standards committee who are ready to submit their final draft of the data collection report may submit their final draft on April 25 in lieu of the mini report, but have until May 16, 2014, to submit their final draft as originally scheduled.
- **Closing the Team Recommendations and AIPs:** Committee members were advised that all team recommendations and actionable improvement plans must be closed when submitting the final data collection report. Pending or on-going items must be addressed before submitting the final mid-term report to ACCJC.
